## Sandwich-panels with mineral wool-core

product composition<sup>1</sup>:  
The composite panels consist of steel sheets with organic coating and a mineral wool insulation core.

### 1. Components

**Cover sheets:**  
For cover sheets, continuously strip galvanized steel according DIN EN 10346 is used. The sheets are primer-coated and have 25 µm polyester top-coating as standard (plastic-coating available as alternative). Coated material is primarily purchased from suppliers & vendors in Europe.

**Mineral wool<sup>2</sup>:**  
The insulation core consists of mineral wool with marginal addition of thermoset synthetic resin, mineral oils and bonding agents. Mineral wool is regarded as non-hazardous to health in numerous applications. The used mineral wool cores are exclusively purchased from suppliers in the European Union.

### 2. Production

**Energy:**  
For the production process, electrical energy is used. The production facility is heated by natural gas. Emissions to water or air are below permitted limits<sup>3</sup>.

### 3. Logistics

Production site: Blankenhain, Thuringia, Germany

Means of transport: Logistics of finished products are primarily delivered by truck.

Packaging: the following materials are used as packaging material:

### 4. Installation

Custom-made panel lengths and standard-widths help avoiding waste-cut and accumulation of scrap on site. During installation, no environmentally harmful impact is created.

### 5. Usage

Regular cleaning and maintenance contribute to a long product life. During usage, no environmental impact is created.

### 6. Uninstallation and disposal

At the end of their life-cycle, sandwich panels are uninstalled easily. They can either be reutilized or mechanically separated and disposed of as recyclable material. In this process, no environmentally harmful impact is created.
